Instructions to the Parent/Guardian Applying for Camperships:

Campership funds are obtained mainly from two sources. One is the “Bob Jones Campership Fund”, an organization which each year allocates a certain amount of funds to each group requesting them. This organization provides us with approximately 1/3 of our campership income. The second source of campership income is by private donations from businesses and individuals who wish to see that the tradition of “every Scout to camp” continues. Those wishing to make contributions please contact MBAC at (831) 422-5338.

NOTE: Campership applications are NOT registration forms for camp, they are applications for financial aid. Please file the appropriate camp application where necessary. See 5-6-7 below.

1. Due to the large number of camperships requested, they will only be granted to Scouts where are registered in the Monterey Bay Area Council. **Only one session of campership per Scouts will be granted.**
2. Campership Request deadline is June 1. However, because of the processing involved, two or three months in advance is not too soon.
3. **EACH SCOUT MUST USE ONLY ONE FORM**– more forms can be obtained at the Council Service Center by calling (831) 422-5338 or you can photocopy this one.
4. You must answer every question on the form and the form must be **signed**.
5. For NYLT and Eagle Camp, you must file a registration form for camp before or at the same time as you submit this campership. Please wait for you approval notification before paying balance.
6. For Cub Resident Camp or Boy Scout Summer Camp you sign up through your unit, you do not need a camp registration form. **Please do not pay further fees** until you receive notification.
7. For Cub Day Camps you must file a registration form for camp before or at the same time as you submit this campership form and pay a \$30 deposit for camp; (submit deposit with your application for camp, not with this application) but do not pay the full fee, you will not be penalized. Please wait for you approval notification before paying balance.

Please read these instructions carefully. PLEASE DO NOT SEND MONEY with this application. Fees should be submitted following the instructions listed here. This is an application for financial aid, it is NOT an application to attend camp. Thank You.

NOTE: Campership covers Scouts only, not adults.

8. **This application should be mailed directly to the address below. As it contains confidential information you should not give it to your Pack/Troop/Team/Crew Leaders.**
9. Notification of how much your family must pay will be sent to you in June. A total campership is not given, the Scout/parent will be asked to make up difference. Your Scout’s unit can sometimes help out. Your Scout’s popcorn sales or unit money earning projects can help too. The approval will tell you how to submit the balance due and to whom. Let your Unit Leader know how much you are required to submit.
10. You must include the camp and date your Scout is attending. If you do not know ask his Unit Leader.
11. Not fully filling out this form can cause a delay in the processing as it will need to be returned to you for completion.
12. As with any program of this type, the organizations providing the funds are always pleased to receive a thank you letter from the Scouts who have benefited from these funds. Your confirmation letter will tell you which organization provided the funds your son is benefiting from. Thank you letters may be addressed to the BSA office at the address below.
